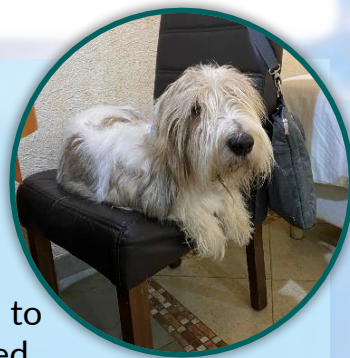

Rip's GRAND Caribbean Adventures

¡Hola! ¡Buenas tardes! Soy un GBGV, mi nombre es Rip.
Oops, wrong language!

I moved to Utila, Honduras, over a year and a half ago. I have some fun stories to share about my new adventure living in a jungle on an island in the Caribbean. My folks, Lara and Paul, came up with this grand plan to move 3000 miles away from Indiana. And because of me being a big boy, they opted to drive from Indiana to Honduras. Driving started out as a joke as they researched everything else possible, from flying to taking a freight boat, but in the end, driving made the most sense. They loaded me and my bichon brother, Bernard, and my terrier mix sister, Noriega, up just before Christmas 2021, and off we went.



Did you know there are rules in every country regarding bringing pets into a country? For Honduras, dogs must have a current rabies and leptospirosis vaccination and proof of deworming and tick prevention. We don't need a USDA vet certificate, although it is recommended to get one. Since we were driving, the USDA wouldn't give us one as we were going through Mexico and Guatemala. Now Mexico doesn't care much about dogs; no one checked anything.



Guatemala, on the other hand, they do care! Mom had to take us to a veterinarian in Mexico and get us examined and bloodwork done. The vet printed this fancy document with his photo, and \$100 later, we were on our way.

He was a friendly veterinarian. Mom had to go to another one first, as we had no appointment. She said she picked a smaller town in Mexico that seemed to have an excess of veterinarians, so we would be sure to find someone to help us. It took three hours to cross from Mexico to Guatemala. Mom was sure to have piles of paperwork for us in triplicate, which satisfied the officers.

It took us eight days to get to Honduras as we were only driving during the day (for the most part. Except for the one-night Mom got us kicked out of a hotel in Palenque, Mexico because we were making noise; that's a story for another time. Mom will tell you, do not compare barking dogs to noisy children in Mexico.) I spent plenty of time being proud of myself, bellowing to keep people away from the car.

My favorite part of the trip was taking the big ferry from the mainland in Honduras to Utila. It took about an hour, and we got to ride up top!

I have many more stories to share with you about my adventures here in Utila! If you have pet-related travel questions, send them my way, and I'll pass them along to Mom to see if she can help.

INAUGURAL CLINICAL STUDY

Long Leg

There is exciting news to report on the commencement of the first "GBGV breed specific" clinical study through the efforts of the partnership between the GBGVCA Breed Preservation Committee and the GBGVCA Foundation.

Since the formation of the Foundation in 2016, there have been specific fundraisers hosted by the parent club whose proceeds were designated for a future long leg study and those funds gifted to the Foundation. In addition, there have also been donations from private individuals directly to the Foundation earmarked specifically for the long leg research. The joint committee determined there was a need and adequate funding to begin researching the parameters of an initial clinical study.

With the tenure that Corey and Brent have had over the years with the staff at the University of Missouri on numerous other projects, they have assisted in facilitating extensive communication with Dr. Gary Johnson, Associate Professor/Veterinary Genomics and Liz Hansen, DNA Research Information Specialist, of Animal Molecular Genetics Laboratory at the University of Missouri, College of Veterinary Medicine. These talented professionals have been very generous with their time and knowledge to educate our joint committee and have provided the protocol necessary to conduct a Whole Genome Sequencing (WGS) of the long leg study for our noble hounds.

Brent and Liz have had extensive email discussions, questions and answers about this study and the probable expectations and outcomes. We felt providing the following actual quote would be more transparent to our membership of the process:

*'It is important to understand that mutation discovery isn't like manufacturing widgets. It's not as simple as put stuff in this end, and an answer spits out the other end! Sometimes it gives us a good answer, we identify a mutation and everything is good. But it's also not unusual that we cannot find what we're looking for with today's technology. The sequence data doesn't go away, and continues to be useful, so as new analysis tools become available, we go back and re-analyze our unsolved cases, to see if something shows up now, with better tools. We have recently found some mutations that had been pretty elusive years ago when we first ran the sequences. We use cutting edge analysis tools, and have probably identified more disease-causing mutations than any other lab doing this sort of research - but we also do have unsolved problems that we keep revisiting, and will keep poking away at until we do figure out the answers. There is not a way to know if this is going to be an easy find, or one that makes us scratch our heads and have to keep working on for a while, until we try. We want to solve it, we throw everything we know at it, but sometimes it's not a simple answer and it takes more time than we'd ideally like it to.'* Liz Hansen

INAUGURAL CLINICAL STUDY

To begin the process, Dr. Johnson and Ms. Hansen have identified specific dogs to be used for the initial study and the DNA samples which will be needed. The scope of the project as described is as follows:

University of Missouri states that for the study to be initiated they need the following:

- A sample of the sire and dam of a specified litter that produced “affected” dogs
- From that litter 2 samples of “affected” dogs
- From that litter 2 samples of “non-affected” dogs
- All samples must be from the same litter

We are pleased to report that many of the requested DNA samples have already been collected and are in the possession of the University of Missouri, Animal Molecular Genetics Laboratory. The remaining few are in process and we sincerely appreciate the cooperation of our breeders and their assistance in providing these requested DNA samples.

Our joint committee has spent significant time and effort through numerous phone meetings, emails and texts to compile the information the Foundation Board of Directors needed to support the approval and funding of this project since the needed funds lie under the aspic of the GBGVCA Foundation, Inc. In closing, the joint committee is pleased to report that the Foundation Board of Directors approved the following at their last meeting on July 12, 2023:

The GBGVCA Foundation, Inc. has approved to partner with the Animal Molecular Genetics Laboratory at the University of Missouri, College of Veterinary Medicine and commission an initial Whole Genome Sequencing (WGS) of the long leg study. Should the initial study not produce anything plausible, a second study has been approved with DNA samples of specific dogs as identified by the staff at the Animal Molecular Genetics Laboratory. The Foundation Board of Directors has also approved to provide funding to reimburse the breeder/owner the costs of collection/shipping of any DNA blood samples of any dog identified needed for continuation of the first clinical study or to initiate the second clinical study. For reimbursement valid receipts/invoices must be remitted to the GBGVCA Foundation Treasurer.

On behalf of the joint Breed Preservation Committee, we wish to thank all who have assisted in bringing this first clinical study to fruition and also to the Foundation Board of Directors for their vision in protecting the future of our noble breed.
